  - SD Contract expires; extension requests should be made for a year or two, without changes.

#### RFQ For CM/GC Services Selection Process /Construction Oversight Committee

- RFQ for construction manager/general contractor services out for bid as of 12/29/2023. A copy was also sent by email to each DOMES Board member.
  - Two of the four interested construction companies are local and two are regional.
  - Local Contractors with interest
    - Greenhut Construction Representative states they plan to submit a proposal
    - Wharton-Smith Emailed with questions regarding project
    - Ajax Construction acknowledged receipt of the RFQ
- Selection Process
  - Selection Committee will be comprised of the DOMES Board members who would:
    - Receive proposals
    - Approve/Deny proposals
    - DOMES Board members will select a member of each respective county staff to have as an appointee to assist or advise in making decisions on the proposals.

#### Legislative funding Update:

- Senator Broxson is understanding about timeline for groundbreaking and his duties not aligning and will work with DOMES moving forward on the groundbreaking as best possible.
- Local Funding Initiative legislation has been introduced and DOMES submitted through Representative Andrade carry it on the House side.
- Grant extension will use monthly progress reports to continue to provide updates.
- The remaining funds from the 2022 FDLE grant of \$500,000 will be used to execute the next design steps of the project.
