# 1. Discussion on Item I (DOMES Capital Funding Interlocal Agreement)

# State Funding

Mr. Schebler opened the discussion stating he submitted the \$1.5M budget request to State Representative Andrade's office (District 2). The attestation form still needs to be signed.

## **Local Funding Discussion**

Mr. Coffey shared suggested funding agreement changes by Escambia. After discussion, the DOMES Board members agreed to the following changes being made to the funding agreement:

**Section 3 (a)** Remove the word "or 22,250 sq ft total.

**Section 4 (g)** Now reads, in addition to the Facility, the COUNTIES anticipate maintaining a long-term lease with Ascension Sacred Heart Hospital to serve as a satellite office for the District 1 Medical Examiner as long as it remains fiscally feasible as determined by the DOMES Board. Exhibit A (conceptual plan) attached.

**Section 4 (e)** Everything after the first reference to \$750K is to be deleted.

Lynn Hoshihara and Craig Coffey will finalize the recommended changes. A copy will be sent to Mr. Schebler who will distribute to all DOMES Board members for review prior to going before each respective BOCC for approval at upcoming BOCC meetings.
